

PROCEEDINGS OF GOVT. OF KARNATAKA

Sub: Order for having granted permission/approval to run English Medium from 5th Std., by getting 1st to 4th Standards converted to Kannada Medium in Sri Adichunchanagiri English Medium School, Kuvempunagara, Mysore run by Sri Adichunchanagiri Education Trust (R), Adichunchanagiri Kshethra, Belluru, Nagamangala Taluk, Mandya District.

Read: 1) Letter No.: C7(3) P.E.-Approval 25:90-91 of dated: 18.07.94 of the Director (P.E.), Department of Public Instructions, Bangalore.

2) Requisition dated: 17.06.94 of Sri Adichunchanagiri Education Trust (R), Adichunchanagiri Kshethra, Belluru, Nagamangala Taluk, Mandya District.

PROPOSAL:

1) Sri Adi Chunchanagiri Education Trust (R), Sri Adi Chunchanagiri Mutt, Belluru, Nagalamangala Taluk, Mandya District have officially opened Sri Adichunchanagiri English Medium School in Kuvempunagara Extension of Mysore City from the Academic Year 1990-91 and have requested to accord permission to the said School.

2) School within the limits of the Department of Public Education as read in Ref. (1) has been commenced from the year 1990-91. And they have stated that as per the Education Policy of this School, there is no provision to accord permission for English medium Primary School. But, as per the other Rules of Primary School Education Code, the School is running in a building having best teaching rooms and informed that they have necessary furnitures, teaching materials and qualified teachers.

3) The Applicant Educational Institution by submitting an Affidavit on a Stamp paper requesting the Govt. to accord permission/approval to run English Medium School from 5th Std., by converting 1 to 4th Standard to Kannada Medium, as per the Current Policy of the Govt. On verifying all these points, the Govt. has passed an Order as hereunder:-

Govt. Order No.: from E.D.3 to 94, Bangalore, dated: 11.94.

1) On detailed inspection of the Proposal granting approval for English Medium from 1st Standard itself to Sri Adi Chunchanagiri English Medium School, Kuvempunagara, Mysore, run by Sri Adi Chunchanagiri Education Trust (R), Sri Adi Chunchanagiri Mutt, Bellor, Nagamangala Taluk, Mandya District, since there is no provision for English Medium from 1st Standard itself as per the Linguistic and Medium of Education Policy of the Govt., the permission is hereby denied/rejected for English Medium from 1st to 4th Standard.

But,

2) the Govt. has accorded approval/permission subject to the below mentioned terms & conditions that, as per the other points verified in the proposal and as per the Linguistic and Education Medium Policy of the Govt., to run English Medium Primary School from 5th Standard by getting the 1st Standard to 4th Standard converted to Kannada Medium stage by stage by Sri Adichunchanagiri English Medium School, Kuvempunagara, Mysore, with permanent un-aid.

TERMS & CONDITIONS:-

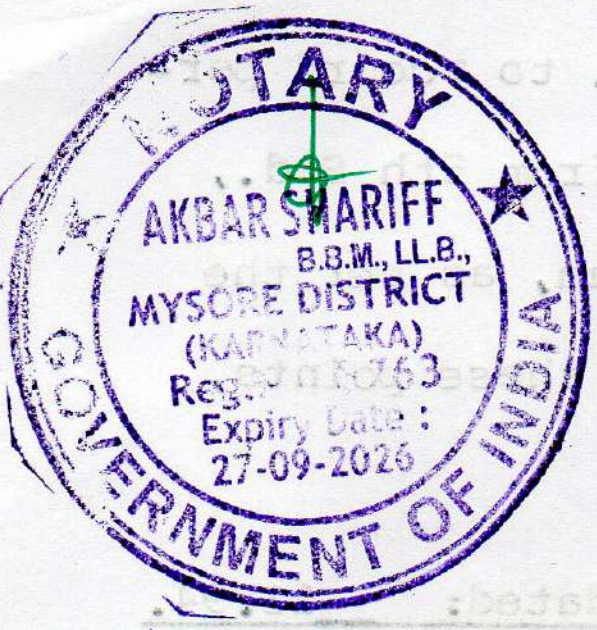
Should run the School permanently un-aid. And your Institution should not expect any type of financial aid or grants from the Govt. towards your School.

3) As per the current policy of the Govt.



02. The Institution shall run the School by abiding to the rules of Primary School Education Code and by abiding to the Orders and Guidelines passed/passed from time to time by the Govt. and the Department of Education.

03. The Institution shall not open any additional **Sections** in any Standard of their School without the prior permission of the Department of Education.

04. The Institution should ~~maintain~~ the Admission of the students not exceeding 50 in each section of it's school.

05. Institution should get therecognition to it's Section from the concerned Officers of Education Department and shall get the same renewed on time every year.

06. Should follow all the terms and conditions imposed about the policy of Linguistic in Govt. Order No.: ED 28___ 94, dated: 29.04.1994, without fail.

07. If the School is not run in accordance with the rules of code of Paimary School Education and if the ^{other} terms & conditions imposed herein are not followed, then, the approval accorded to this Institution through this Order will be withdrawn.

08. If the School is not run by changing to Kannada Medium from 1st Standard w.e.f. the Academic year 1994-95, then, the Approval granted through this Order shall be cancelled.

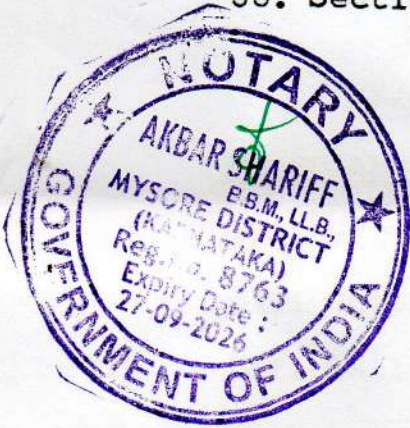
